

MEMBERSHIP OF UKACCS LIAISON GROUP

What this paper is about

The paper looks at the membership of the Liaison Group in the light of the CAA's latest passenger statistics. The present criterion for membership of the Liaison Group is that an airport should have a passenger throughput of 0.6 mppa or more.

Points for Discussion

There are none - the paper seeks only to bring members up to date on the Group's membership.

Points for Possible Action

This year there are no airports where the consultative committee becomes eligible for membership of the Liaison Group. Indeed, Coventry (0.331 mppa) and Norwich (0.583 mppa) no longer meet the Liaison Group's criterion

Introduction

1. The present criterion for membership of the Liaison Group is that an airport should have a passenger throughput of 0.6 mppa or more. There are currently 23 UK airports represented on the Liaison Group. This report provides an update on the air traffic growth at UK airports and gives details of those airports which now fall within the Liaison Group's admission criterion.

Air Traffic Growth

2. The Civil Aviation Authority (CAA) published the 2008 air traffic statistics for UK airports in mid March. The figures show that (excluding the Channel Islands and the Isle of Man) UK airports handled just over 236 million passengers in 2008, a decrease of 1.7% on 2007.
3. Passenger traffic at the five main London airports - Heathrow, Gatwick, Stansted, Luton and London City - fell by 2% to a total of 137 million passengers. Only at London City (12%) and Luton (3%) was there any growth.
4. Passenger traffic at the UK's other airports fell by 2% to a total of 99 million passengers. Among the UKACCs airports, there was growth only at Belfast City (18%), Birmingham (4%), East Midlands (4%) and Bristol (6%).
5. Air transport movements (landings and take-offs of commercial aircraft) at UK airports fell to 2.327 million, a decrease of just over 2% compared with 2007. The London airports handled 1.077 million air transport movements (atms), down 0.92% on 2007. Other UK airports reached a total of 1.25 million, a decrease of just over 3% on 2007. Among UKACC member airports there were increases at London City (9%), East Midlands (8%), Luton (3%), Bristol (2%), Cardiff (2%) and Belfast City (1%). All other UKACCs airports showed reductions notably at Durham Tees Valley (17%) and Inverness (10%)

Membership of the Liaison Group

6. Annexed to this paper is a list showing the 2008 passenger throughput and total movements for the major UK airports. Those airports which are designated for the purposes of consultation under s. 35 of the Civil Aviation Act 1982, and should thus have a consultative committee, are asterisked.
7. It will be noted that the 23 present members of the Liaison Group are all from airports with a passenger throughput in excess of 0.600 mppa.

Possible new members

8. As previously reported the Liaison Group does not include representatives from Belfast International, Jersey, Exeter, Guernsey or the Isle of Man. The position on these committees is as follows:
 - Inquiries show that Jersey Airport has no consultative committee or equivalent
 - Guernsey's equivalent is the *Transport Users Committee* whose remit covers the port and airport. They were invited to join the group some time ago but there was no response.
 - Likewise Ronaldsway Airport (Isle of Man) was sent an invitation some time ago but there was no response.
 - Exeter declined membership but said they would keep a watching brief on the work of the Liaison Group.

- Belfast International was sent a second invitation but no response was received. From the draft Noise Action Plan for the Airport it is noted that they do not in fact have a Consultative Committee – it is an action point for 2009. Their membership of the Liaison Group needs to be reviewed after the new Committee has been set up.
9. It should also be noted that Norwich and Coventry who, on the basis of their passenger figures for 2007, were eligible for membership were sent invitations last year. Neither Committee responded to the invitation. However, on the basis of the 2008 figures these Committees are no longer eligible for membership of the Liaison Group.
 10. If all eligible airports were to join the Group it would have 28 members.
